

# **South West Integrated Clinical Academic (ICA) Programme**

**HEE-NIHR Post-doctoral bridging  
award (2021/22)**

### Introduction

Health Education England (HEE) and the National Institute for Health Research (NIHR) have established an overarching Integrated Clinical Academic (ICA) programme for non-medical healthcare professionals.

'Clinical academics are clinically active health researchers. They work in health and social care as clinicians to improve, maintain, or recover health while in parallel researching new ways of delivering better outcomes for the patients they treat and care for'

(Building a Research Career, NIHR 2015)

The ICA programme is intended to increase research capacity in order to improve health and healthcare, by developing people with the potential and aspiration to become leading clinical academics and independent researchers in the future.

This year (2021/22) we have secured local funding to support a number of post-doctoral bridging awards for non-medical clinical academics from the South West region. These awards offer the unique opportunity to complete an individualised, structured, twelve-month period of training and development for those looking to undertake a post-doctoral fellowship. With their clinical academic supervisor, successful individuals will have the opportunity to design a bespoke educational programme tailored to suit their specific clinical academic needs and aspirations.

The awards can be completed on a full or part-time basis, as long as all costs remain within the maximum funding envelope of £25,000. Proposals should align their organisations research priorities and the HEE Mandate objectives.

### Eligibility

The awards are open to Allied Health Professionals, Chiropractors, Non-medical Public Health Speciality Trainees, Nurses, Midwives, Optometrists and Dispensing Opticians, Pharmacists and Pharmacy Technicians, Practitioner Psychologists, Healthcare Scientists and wider Dental Team Professions. To be eligible for one of these awards you will need to provide evidence that you have the following:

- Current registration with a relevant regulatory body as per ICA programme requirements (<https://www.nihr.ac.uk/documents/heenih-ica-programme-eligible-professions-and-regulators/12204>)
- Applicant must be employed by a provider of health and/or care services that is providing at least 50% of its services free at the point of delivery. The applicant must also be spending at least 50% of their current role delivering health and/or care services which are free at the point of delivery.
- The health and/or care services are provided within the following STPs: Cornwall and the Isles of Scilly, Devon, Dorset, Somerset, Bristol, North Somerset and South Gloucestershire, Bath, Swindon and Wiltshire, and Gloucestershire.
- Applicants must hold a relevant PhD or Prof Doc (see eligibility criteria <https://www.nihr.ac.uk/documents/ica-professional-doctorates-eligibility-criteria/12291>), or have submitted their thesis for examination at the time of application. Applicants must have been awarded their Doctorate before the start of the award (latest start date: 31<sup>st</sup> March 2022).

## HEE-NIHR Southwest ICA Post-doctoral Awards 2021/22

- For the post-doctoral bridging support, being a current or previous ICA, Clinical Academic Training (CAT) or Healthcare Science (HCS) award holder is desirable but not essential.
- Three years post-registration practice experience
- Support from your line manager to undertake the award
- A keen interest and clear suitability for a senior clinical academic career
- Mentorship from a named clinical academic supervisor (identified by applicant)
- Access to a bespoke educational programme related to specific aspects of the research methodology or data analysis. This could include an academic module, a short course or further accredited academic training
- The opportunity to develop links with an existing clinical research team (identified by applicant)

If you have previously received a South West internship or pre-doctoral award, you may apply for this post-doctoral award. Provide clear evidence of the outcomes of this award in your application. If you have applied previously for this award and been unsuccessful, you are welcome to apply again. You are expected to take up the award between 1<sup>st</sup> September 2021 and 31<sup>st</sup> March 2022 and to complete the award within 12 months. Requests for adjustments will be considered on an individual basis. You can

## How much is the award and how can the funding be used?

Each successful applicant will be awarded up to £25,000 to cover costs including salary backfill, incidental costs, research and clinical supervision, and formal education costs. Suggestions on how the budget can be spent are presented below;

**Clinical backfill:** it is recognised that this may form the main budget expenditure. The most appropriate backfill arrangements can be decided by the awardee and their line manager.

**Research project:** this could include expenses related to the applied research objectives e.g. patient and public involvement, digital voice records, reference management systems, dictation services etc.

**Training and support:** It is essential to have academic mentorship throughout the award. Ideally this support should be from a University within the South West region, however it is recognised that some professional groups may have to find this support from outside of the region. It is recommended that academic supervision costs do not exceed 20% of the overall spending plan. In addition to academic supervision, it may also be appropriate to access further formal courses, visits to other centres, personal coaching, informal leaning and access to relevant workshops. All of this should support the individual in applying for further post-doctoral level fellowship funding to progress their clinical academic career.

**Dissemination costs:** an element of the award is to disseminate the findings through publications and/or conference presentations. Therefore the award can be used to fund conference or publication costs. It is also anticipated that each successful applicant will produce a poster for HEE working across the south west.

**The amount awarded will be paid directly to the awardees employer.** It is recommended that the spending plans are checked by finance teams prior to submission.

### Monitoring and expectations

Successful applicants will be expected to attend two sessions with holders of Southwest ICA awards. The sessions will offer opportunities to engage with a peer group, review your progress and consider requirements for application to NIHR ICA awards. You will be required to present some elements of your award activity such as:

- A research protocol for scientific review
- A PPI review
- Advanced fellowship of clinical lectureship application for review

A written progress report will be required after 6 months (maximum of 2 pages) to provide an update on progress with objectives, challenges and successes, any amendments to plans (where applicable) and priorities for the remaining period.

A final report will be completed at the end of the award (maximum of 4 pages) to provide a summary of achievement of objectives and outcomes, challenges and successes, financial summary and future plans.

Prior to submitting an application, it is recommended that applicants contact the research leads within their NHS Trust to discuss applying for this award and investigate what support and help is available within the organisation. You will also require support from a clinical academic supervisor and some academic contacts for higher education institutes are included below.

Please submit a completed checklist (see Appendix 1) and all application documentation to [ICA.HEESW@uwe.ac.uk](mailto:ICA.HEESW@uwe.ac.uk): by **Midday, Friday 28<sup>th</sup> May 2021**. Please include the checklist, your CV and cover letter as one document where possible (either word document or pdf). Emails sent from work email addresses will be accepted in place of written signatures.

Applications will be reviewed and assessed. Potential candidates for the awards will be invited to a panel interview on either Wednesday, 16<sup>th</sup> June 2021 or Thursday, 17<sup>th</sup> June 2021. You will have 7-10 days notice if you are invited to interview. Interviews will be scheduled for 30 minutes and will occur virtually.
